AS OF JUNE 30, 2021, THERE WERE 12,176 ACCESSIONS IN THE GARDEN'S LIVING COLLECTIONS, COMPRISED OF 7,774 DIFFERENT KINDS OF PLANTS, 11% OF WHICH ARE OF WILD COLLECTED ORIGIN. PROGRAM SERVICE REVENUE INCLUDES PLANT SALES AND THE PREVIOUS YEAR SAW MORE THAN 7,587 PLANTS SOLD TO THE COMMUNITY.
